TO ANY DAMAGE TO ANY OF THE
RIVERS DOWN STREAM, PAST POPULATED
TOWNSHIPS

FENCING ANY LITTLE CREEKS OR
DRAINS PROHIBITIVE BECAUSE OF

LIMITED
STEEPNESS AND ACCESSIBILITY

IT WOULD APPEAR THAT THE PLAN DOES NOT RECOGNISE THE MAJOR CAUSE OF CONTAMINATION OF THE RIVERS WHICH IS THE POLLUTION OF ALL THE INDUSTRIAL AND RESIDENTIAL AREAS THAT ARE CONTRIBUTING TO THE PROBLEMS.

HISTORY TELLS US THAT THE MAJORITY OF SETTLEMENTS EARLY AND LATER WERE ESTABLISHED NEAR OUR RIVERS AND WATERWAYS AND I WOULD SUGGEST THAT BEFORE YOUR ORGANISATION STARTS PENALISING THE HIGHLAND COUNTRY FARMERS YOU INVESTIGATE EVERY RIVER BANK OF ALL RIVERS IE WHIRAU AND WAIKATO AND ALL THEIR CONTRIBUTARIES AND SEARCH FOR ANY POLLUTION THAT IS SEEPING THROUGH INTO OUR WATERS.
