Goat Dairy Farming.

We are NOT the same as a Cow Dairy Operation. The rules proposed in the document, ask for practises that are not relevant to our style of farming.

1, My Farm is a Dairy Goat Operation. We currently do not have any way of measuring our environmental impact. The Overseer program that Dairy Farmers use, does not at present, work for our farming operation.

Thus we are unfairly treated with this proposal at this time.

2, Riparian Fencing. We cut and carry all food to the animals. They never get to roam free on the property. Fencing off the water ways has NO purpose, BUT it can be a safety issue when cutting. The mowers can become in tangled in the wires. Easily overcome with rules if the farming practise changes, fencing must be installed.

3, A lot of Goat Farmers have already done a lot to be user friendly to the environment. (Lack of Nitrogen use being one of these) Some of the proposed rule changes will disadvantage them with a lot of added cost to modify their systems when the one they have just installed and works, has now been deemed as obsolete.
