One of the many clauses in this proposal that I disagree with is (3.11.5.2) the council's ability to tell us (farm owners/sharemilkers) when and when not to graze or grow crops on land greater than 15 degree slopes. This will have a huge impact on all farmers and stock health will suffer. The land that is less than 15 degrees will get over used which will result in nitrogen leeching and pasture damage. These are things that your proposal is trying to avoid.
Has anyone looked into how much dairy/sheep and beef land in NZ is over 15 degrees in slope? where do you expect stock to go during the winter months?
The programme overseer is said to be 20-30% inaccurate, nitrogen is a main source of supplement feed for many farmers and yes, a lot of farmers do over use nitrogen and we can all possibly use less but 30% (+ or -) is just not good enough for me.
We all want the future generations to enjoy NZ's rivers and environment but you are trying to achieve the unachievable and will cripple the agri industry and possibly the NZ economy in the process.——
