


Map 1: Waikato region




Map 2: Area covered by the Vision and Strategy for the Waikato and Waipa Rivers














Map 22: Fresh water bodies and wetlands to be considered by LF-M9




Map 24 has been inserted as a result of Environment Court decision Opoutere Ratepayers and


Map 25: Significant transport corridors




Map 26: Significant transport corridors (Greater Hamilton)




Map 27: Overview of outstanding natural features and landscapes (ONFL) maps




Map 28: NFL 1 – Tongariro National Park




Map 29: ONFL 2 – Kaimanawa Mountains




Map 30: ONFL 3 – Northern Herangi Range




Map 31: NFL 4 – Mount Karioi












