This document represents an application to **Trojan Marine Services** to have your marine work booked in; mooring inspected & serviced or other marine work carried out. It outlines the various payment terms & service options available, & gathers some of the basic information about your particular job. Once the preferred options are selected & authorisation is signed & returned, **Trojan Marine Services** will deem this document as order to carry out the marine work as requested, & against the managing authority's recommended standards where applicable.

As the client you can select either of the following inspection & service options:

1. **Have your mooring inspected only, without service**, resulting in a mooring inspection report only.
2. **Be present at the inspection of your mooring to witness the mooring service.** **Trojan Marine Services** welcomes client attendance. However, you will have to make personal arrangements to be onsite when **Trojan Marine Services** notifies you of the service day.
3. **Have your mooring inspected & maintained if necessary**, from which a full work list will be provided with the invoice.
4. **Upgrade the size of your mooring** upon agreement from your local Harbour Master.
5. Inform if your mooring is booked with another contractor (please confirm cancellation with other contractor).
6. Book in other marine work.

**Payment Terms:**

1. Inspection & maintenance charges are on a **7 day invoice**.
2. Interest will be charged on overdue accounts at 12% per annum. Any debt collection fees will be at the clients cost.
3. Only upon full payment of the **7 day invoice** will a copy of the inspection report be sent to you & the managing authority.
4. Equipment supplied will remain the property of **Trojan Marine Services** until accounts are paid in full.
5. **Trojan Marine Services** reserves the right to remove supplied equipment on unpaid or outstanding accounts.
